- Ensure that safety chains are connected to tow vehicle at all times whilst on the Club grounds
- There is to be no more than **two (2)** people to travel on the mechanical ramp when launching the boat
- Strictly no riding in or on the boat or trailer whilst moving around the Club Grounds
- No skiing to or from the pontoons
- No swimming from or around the pontoons
- No boating north of the railway bridge
- No consumption of alcohol on the pontoons or around the boats
- No taking command of a boat whilst under the influence of alcohol
- Do not cause unnecessary disruption or delay in the pit area while launching or retrieving your boat
- No leaving vehicles parked in the pit area
 - ** Exception for 2 x Disabled Vehicles (Blue parking bays) disabled permit to be displayed
 - ** Exception for 1 x Race Boat Vehicles (White parking bays)
- No parking in front of sheds (tow away zone) Tenant requires 24 hour access
- No parking of vehicles or trailers on the grass area in front of Club House
- No boat to be on the water without current scrutineering having been completed
- No boat on the water without current Insurance coverage
- Must abide by all State Boating Regulations whilst on the water
- Must display current year Club scrutineering sticker
- Must only tow water-skiers & wake boarders **between** the hours of **one (1) hour before sunrise to one (1) hour after sunset**, in accordance with Marine Safety Act
- Must not use boat after sunset without approved navigation lights
- Must not drive my motor vehicle in excess of **20km/ph from the access road commencing at the first shed & car park, pit area 5km/ph** and not more than **50km/ph on the entry road (Gate to the first shed)**
- The Club key is issued to the member only and is your personal key, this is not to be handed to others
- Must lock the Club gate when entering and leaving the Club grounds
- Keep clear of the race course whilst race boats are practicing – race boats have the right of way
- Keep clear of the slalom/jump course whilst boats are using the course
- I will undertake to uphold all the above mentioned points and all MRSBC rules and regulations
